

NOTICE OF PROPOSED CLASS ACTION SETTLEMENT

Minicucci, et al. v. Northeast Rehabilitation Hospital Network

Case No. 218-2025-CV-00897

Superior Court of Rockingham County, New Hampshire

A court has authorized this notice. This is not a solicitation from a lawyer.

You are not being sued.

Please read this Notice carefully and completely.

- A Settlement has been reached with Northeast Rehabilitation Hospital Network (“NRHN” or “Defendant”) in a class action lawsuit. This case is about the targeted cyberattack on NRHN's computer systems that occurred in May 2024 (the “Data Incident”). Certain files that contained private information were accessed. These files may have contained personal information such as names; medical histories and treatment information; patient account numbers; physician information; prescription information; medical billing/claims information; other health insurance information; Social Security numbers; credit card information; financial account information; and other sensitive data.
- The lawsuit is called *Minicucci, et al. v. Northeast Rehabilitation Hospital Network*, Case No. 218-2025-CV-00897. It is pending in the Superior Court of Rockingham County, New Hampshire (the “Litigation”).
- NRHN denies that it did anything wrong, and the Court has not decided who is right.
- The parties have agreed to settle the lawsuit (the “Settlement”) to avoid the costs and risks, disruptions, and uncertainties of continuing the Litigation.
- NRHN's records indicate that you are a Class Member, and entitled to benefits under the Settlement. You may have received a previous notice directly from NRHN.
- Your rights are affected whether you act or don't act. ***Please read this Notice carefully and completely.***

Basic Information

1. Why was this Notice issued?

The Superior Court of Rockingham County, New Hampshire, authorized this Notice. You have a right to know about the proposed Settlement of this class action lawsuit, and about all of your options, before the Court decides whether to grant final approval of the Settlement. This Notice explains the lawsuit, your legal rights, what benefits are available, and who can receive them.

The lawsuit is called *Minicucci, et al. v. Northeast Rehabilitation Hospital Network*, Case No. 218-2025-CV-00897. It is pending in the Superior Court of Rockingham County, New Hampshire. The people that filed this lawsuit are called the “Plaintiffs” (or “Class Representatives”) and the company they sued, Northeast Rehabilitation Hospital Network, is called the “Defendant.”

2. What is this lawsuit about?

This lawsuit alleges that during the May 2024 targeted cyberattack on NRHN's computer systems, certain files that contained private information were accessed. These files may have contained personal information such as names; medical histories and treatment information; patient account numbers; physician information; prescription information; medical billing/claims information; other health insurance information; Social Security numbers; credit card information; financial account information; and other sensitive data.

3. What is a class action?

In a class action, one or more individuals sue on behalf of other people with similar claims. These individuals are called the “Plaintiffs” or “Class Representatives.” Together, the people included in the class action are called a “Class” or “Class Members.” One court resolves the lawsuit for all Class Members, except for those who opt out from the settlement. In this Settlement, the Class Representatives are Diane Minicucci, Ellen Lavoie, Adam Bagni, and Frank Ciaravolo. Everyone included in this Action are the Class Members.

4. Why is there a Settlement?

The Court did not decide whether the Plaintiffs or the Defendant are right. Both sides have agreed to a Settlement to avoid the costs and risks of a trial, and to allow the Class Members to receive benefits from the Settlement. The Plaintiffs and their attorneys think the Settlement is best for all Class Members.

Who is in the Settlement?

5. Who is included in the Settlement?

The court has defined the Class this way: “All individuals residing in the United States whose Private Information was or may have been compromised, impacted, or affected in connection with the Data Incident discovered by NRHN in May 2024.”

6. Are there exceptions to being included?

Yes. Excluded from the Class are: (1) the Judge in this case, and the Judge’s family and staff; (2) NRHN any businesses it owns or is owned by, any companies that came before or after it, and any businesses where it or its parent company has control, as well as its current and former officers and directors; and (3) anyone who validly excludes themselves from the Settlement.

The Settlement Benefits

7. What does the Settlement provide?

All Class Members may select **one** of two Cash Payment options:

OPTION A: Documented Losses

- If you had documented expenses, or suffered losses, because of the Data Incident, you can get back up to **\$5,000.00**

OR

OPTION B: Alternate Cash Payment

- Receive a one-time **\$75.00** cash payment

There is an aggregate cap of \$500,00.00 on these payments. This means that if the total value of payments claimed is over \$500,000.00, everyone’s payments will be reduced pro rata so that they add up to \$500,00.00.

In addition to the Cash Payments to Class Members, NRHN agrees to spend at least an additional \$500,000.00 to enhance its computer systems and internal security protocols.

The Cash Payment Options are explained below.

CASH PAYMENT A – DOCUMENTED LOSSES. If you incurred actual, documented out-of-pocket losses due to the Data Incident, you can get back up to **\$5,000.00**. The losses must have occurred between May 22, 2024, and February 17, 2026.

This benefit covers out-of-pocket expenses like:

- losses because of identity theft or fraud
- fees for credit reports, credit monitoring, or freezing and unfreezing your credit
- cost to replace your IDs
- postage to contact banks by mail

You need to send proof, like bank statements or receipts, to show how much you spent or lost. You can also send notes or papers you made yourself to explain or support other proof, but those notes or papers alone are not enough to make a valid claim.

CASH PAYMENT B – ALTERNATE CASH PAYMENT. Instead of a payment for documented losses, you may claim a one-time **\$75.00** cash payment. You do not have to provide any proof or explanation to claim this payment.

8. What claims am I releasing if I stay in the Class?

If you stay in the class, you won't be able to be part of any other lawsuit against NRHN about the issues that this Settlement covers. The "Releases" section of the Settlement Agreement (Section X) describes the legal claims that you give up if you remain in the Class. The Settlement Agreement is available at www.NortheastRehabHospitalDataSettlement.com.

Submitting a Claim Form for a Settlement Payment

9. How do I submit a claim for a Settlement benefit?

The fastest way to submit your Claim Form is online at www.NortheastRehabHospitalDataSettlement.com. If you prefer, you can download a printable Claim Form from the website and mail it to the Settlement Administrator at:

10. Are there any important Settlement payment deadlines?

If you are submitting a Claim Form online, you must do so by February 17, 2026. If you are submitting a claim by U.S. mail, the completed and signed Claim Form, including supporting documentation, must be postmarked no later than February 17, 2026.

11. When will the Settlement benefits be issued?

The Court will hold a final approval hearing on March 2, 2026 (**see Question 18**). If the Court approves the Settlement, there may be appeals. We do not know if appeals will be filed, or how long it will take to resolve them if they are filed.

Settlement payments will be distributed if the Court grants final approval, and after any appeals are resolved.

The Lawyers Representing You

12. Do I have a lawyer in the case?

Yes, the Court has appointed attorneys Jeff Ostrow of Kopelowitz Ostrow P.A.; Leanna A. Loginov of Shamis & Gentile, P.A.; Marc H. Edelson of Edelson Lechtzin LLP; and Raina Borrelli of Strauss Borrelli PLLC, to represent you and other Class Members ("Class Counsel").

13. Should I get my own lawyer?

You will not be charged for Class Counsel's services. If you want your own lawyer, you may hire one at your expense.

14. How will Class Counsel be paid?

Class Counsel will ask the court to approve \$500,000.00 as reasonable attorneys' fees and costs of litigation. This amount will be paid by NRHN.

Class Counsel will also ask for Service Award payments of \$2,500.00 for each of the Class Representatives. Service Award payments will also be paid by NRHN.

Excluding Yourself from the Settlement

15. How do I opt out of the Settlement?

If you do not want to be part of the Settlement, you must formally exclude yourself from the Settlement. This is called a Request for Exclusion, and is sometimes also called “opting out.” If you opt out, you will not receive Settlement benefits or payment. However, you will keep any rights you may have to sue NRHN on your own about the legal issues in this case.

If you exclude yourself, you are telling the Court that you do not want to be part of the Settlement. You will not be eligible to receive any Settlement benefits if you exclude yourself.

The deadline to exclude yourself from the Settlement is February 17, 2026.

To be valid, your Request for Exclusion must have the following information:

- (1) the name of the Litigation: *Minicucci, et al. v. Northeast Rehabilitation Hospital Network*, Case No. 218-2025-CV-00897, pending in the Superior Court of Rockingham County, New Hampshire;
- (2) your full name, mailing address, telephone number, and email address;
- (3) personal signature; and
- (4) the words “Request for Exclusion” or a clear and similar statement that you do not want to participate in the Settlement.

You may only exclude yourself—not any other person.

Your Request for Exclusion must be submitted, postmarked, or emailed by February 17, 2026.

Commenting on or Objecting to the Settlement

16. How do I tell the Court if I like or do not like the Settlement?

If you are a Class Member and do not like part or all of the Settlement, you can object to it. Objecting means telling the Court your reasons for why you think the Court should not approve the Settlement. The Court will consider your views.

You cannot object if you have excluded yourself from the Settlement (**see Question 15**)

You must provide the following information for the Court to consider your objection:

- (1) the name of the Litigation: *Minicucci, et al. v. Northeast Rehabilitation Hospital Network*, Case No. 218-2025-CV-00897, pending in the Superior Court of Rockingham County, New Hampshire;
- (2) your full name, mailing address, telephone number, and email address;
- (3) a clear description of all the reasons you object; include any legal support, such as documents, you may have for your objection;

- (4) if you have hired your own lawyer to represent you at the Final Approval Hearing, provide their name and telephone number;
- (5) if you or your lawyer have objected in any other cases in the past five years, list the names, courts, the orders ruling on your objections, and civil action numbers for each of those cases;
- (6) whether or not you or your lawyer would like to speak at the Final Approval Hearing;
- (7) if you plan on calling witnesses or submitting documents at the Final Approval Hearing, provide a full list of both;
- (8) your signature (if you have hired your own lawyer, their signature is not sufficient).

For your objection to be valid, it must meet each of these requirements.

To be considered by the Court, you must file your complete objection with the Clerk of Court by February 17, 2026 must also send a copy of the objection to the Settlement Administrator.

17. What is the difference between objecting and excluding?

Objecting is telling the Court that you do not like something about the Settlement. You can object to the Settlement only if you do not exclude yourself from the Settlement. Excluding yourself from the Settlement is opting out and stating to the Court that you do not want to be part of the Settlement. If you opt out of the Settlement, you cannot object to it because the Settlement no longer affects you.

The Court's Final Approval Hearing

18. When is the Court's Final Approval Hearing?

The Court will hold a final approval on March 2, 2026 at 9:00 a.m. Eastern Time, in Courtroom 6 of the Superior Court of Rockingham County, New Hampshire, at 10 Route 125, Brentwood, NH 03833.

At the final approval hearing, the Court will decide whether to approve the Settlement. The court will also decide how Class Counsel should be paid, and whether to award Service Award payments to the Class Representatives. The Court will also consider any objections to the Settlement.

If you are a Class Member, you or your lawyer may ask permission to speak at the hearing at your own cost (**See Question 16**).

The date and time of this hearing may change without further notice. Please check www.NortheastRehabHospitalDataSettlement.com for updates.

19. Do I have to come to the Final Approval Hearing?

No. Class Counsel will answer any questions the Court may have. You may attend at your own expense if you wish, but you do not have to.

If you file an objection, you do not have to come to the Final Approval Hearing to talk about it; the Court will consider it as long as it was filed on time. You may also pay your own lawyer to attend, but you do not have to.

If I Do Nothing

20. What happens if I do nothing at all?

If you do nothing, you will not receive a benefit from this Settlement.

You will also give up the rights described in **Question 8**.
